The gross charter hire income (revenue) earned by vessel Seamec I during FY 2020-21 is ₹ 84.50 million, which is 3.69% of the Company's total turnover for FY 2020-21. The vessel completed its long-term contract with Oil and Natural Gas Corporation Limited on May 3, 2020 and since then, owing to COVID-19 implications and sluggish market conditions, the vessel remained idle for remaining period.
